# Picnic in the Park 2010

## Terms & Conditions

We thank you for your inquiry regarding participation in Picnic in the Park at the 2010 Cairns Amateurs Carnival.

The Picnic in the Park Packages has been devised to ideally cater for 30 or 60 guests per day of the carnival, however provision can be made for you to include additional guests should the need arise. Take the hard work of setting up out of the equation, and site holders can take the convenient option of one of our packages A or B. Confirmation of your participation is required by Friday 25th of June 2010 by way of completion and return of the attached Booking Form and payment due by Friday 30<sup>th</sup> of July 2010.

Alternatively people can book a site at Picnic in the Park and will once again be able to bring their own tents and other equipment.

### BOOKING PROCEDURES

Sites for the Picnic in the Park are limited due to the space available at Cannon Park racecourse. To secure a site, the Picnic in the Park Site Booking Form must be completed and payment made no later than **Friday 13<sup>th</sup> August 2010**, unless sold out prior to this date. Sites cannot be held without payment.

### SITE PERMITS

Sites are sold based on the different categories of marquee sizing and the number of people being accommodated. Permits will be issued for each day and must be attached to the marquee and produced when requested by Security or Club Officials. Permits must state the site holder's name (as shown on the Booking Form). Sites size must not be exceeded by the site holder (as per the General Terms & Conditions of Ticketing and Entry). Tickets and permits will be issued by mail on or around 17<sup>th</sup> August.

### SET UP & BREAK DOWN OF SITES

Picnic in the Park continues to operate on the basis of site bookings with Security Officers on hand to control entry and positioning of marquees.

Set up details are as follows:

- **A or B Package holders your marquee will be set up and ready from 10am**
- **Permit holders for both Friday and Saturday** - set up will be from 10.00am Wed 1<sup>st</sup> September 2010
- **Permit holders for Friday Only** - set up will be from 1.00pm Thursday 2<sup>nd</sup> September 2010
- **Permit holders for Saturday only** - set up will be after 5.30pm Fri 3<sup>rd</sup> and before 8am Sat 4<sup>th</sup> September 2010.

All marquees are to be erected 3 metres back from the running rail, with the narrowest side facing the running rail. Package D marquees must be erected to the back of the area to allow for smaller marquees at the front. Car passes are provided for the delivery only of catering, marquees, chairs eskies etc. Drivers and passengers in the vehicle must have gate passes or Members Passes. All vehicles must vacate this area by no later than 9am each race day. After the Carnival has been completed, all marquees and property of participants must be removed from the sites by Sunday 5<sup>th</sup> September.

## Terms & Conditions

### BEVERAGES

In accordance with the Far North Queensland Amateurs Turf Club's Liquor License and under the provision of the Queensland Liquor Act 1992, alcohol is not permitted to be brought onto Cannon Park Race Course (which encompasses the Picnic in the Park area) or removed from the area. To cater for the patrons of Picnic in the Park, a bar facility will be provided within this area. Please note that Security will be on the gates and will check all incoming bags & eskies.

### SMOKING

In accordance with Queensland Law, from 1 July 2006 smoking is banned in all enclosed areas and in most of the licensed outdoor areas at the Cannon Park Racecourse. There will be designated areas for smoking only provided. Penalties apply regarding breach of the legislation.

### SECURITY

Security has been arranged for the entire racecourse, which is provided for the protection and control of the general public. Security staff are not responsible for the property within the individual marquees. Should you wish to arrange personalised security for your marquees this will be at your own expense and must be organised through the security providers. The above conditions will be monitored throughout the two (2) day carnival by Security who have controlling authority.

### PARKING

Additional public car parking is available at the rear of the track, behind the Picnic in the Park area. Access is via the side road to the right of the race course.

### ADDITIONAL INFORMATION

- The FNQATC is committed to promoting the socially responsible enjoyment of wagering on the outcome of the races.
- The FNQATC promotes safe and responsible alcohol service and consumption.
- No live entertainment is to be conducted in the area
- No generators or lighting of any kind are to be used in the area
- No banners, corflute signage or advertising of any kind, except as set out in the General Terms & Conditions of Ticketing and Entry.
- No electricity is supplied to any site in the area
- No private portable toilet units of any type are to be erected in the area
- The size of the site booked is the maximum area allowed to be occupied by the site holder. No fencing off of extra area around the booked site is to be carried out.
- Any fencing within the boundaries of the site booked must be securely erected and all star pickets must be capped safely. All ropes and pegs must be clearly marked.
- At the request of the Cairns Police (through the Queensland Police and Liquor Licensing Division) we have been instructed to obtain and distribute the email address details and mobile phone contact (on the day) of site holders to the Police so that they can contact you to make clear to you your obligations under Queensland Liquor Licensing Laws. It is mandatory for you to supply this information on the booking form in the spaces indicated.
- You will be advised prior to the Event as to the closing time of the bars and the vacation of the Picnic in the Park area as set by the Queensland Liquor Licensing requirements. These times must be strictly adhered to.



# Picnic in the Park Packages Inclusions & Costs

## **PACKAGE A:**

A 10 x 10 metre site consisting of:

- An individual Marquee 6m x 10m located within an enclosed area over the Friday or Saturday of the Carnival
- 30 metres of white picket fencing to enclose your Marquee area
- 8 x Tressle tables, 50 x chairs and 1 x large esky
- 2 x Umbrellas and 4 x Outdoor round 4 foot tables
- 60 x Roast Carvery vouchers valued at \$20.00 each
- 120 x Drink vouchers valued at \$2.50 each
- Access to local and southern Bookmakers and TAB facilities

**Package A is based on catering to sixty (60) guests.**

**Package cost \$4,500 per day plus \$20.00 per person for extra guests over 60**

## **PACKAGE B:**

A 6 x 6 metre site consisting of:

- An individual Marquee 6m x 3m located within an enclosed area over the Friday or Saturday of the Carnival
- 18 metres of white picket fencing to enclose your Marquee area
- 4 x Tressle tables, 30 x chairs and 1 x large esky
- 2 x Umbrellas and 3 x Outdoor round 4 foot tables
- 30 x Roast Carvery vouchers valued at \$20.00 each
- 60 x Drink vouchers valued at \$2.50 each
- Access to local and southern Bookmakers and TAB facilities

**Package B is based on catering to thirty (30) guests.**

**Package cost \$3,000 per day plus \$20.00 per person for extra guests over 30**

## **PACKAGE C:**

Set up your own tent on a 6m x 6m site catering for 30 people.

**Site cost Friday \$100**

**Site cost Saturday \$150**

## **PACKAGE D:**

Set up your own tent on a 10m x 10m site catering for 60 people.

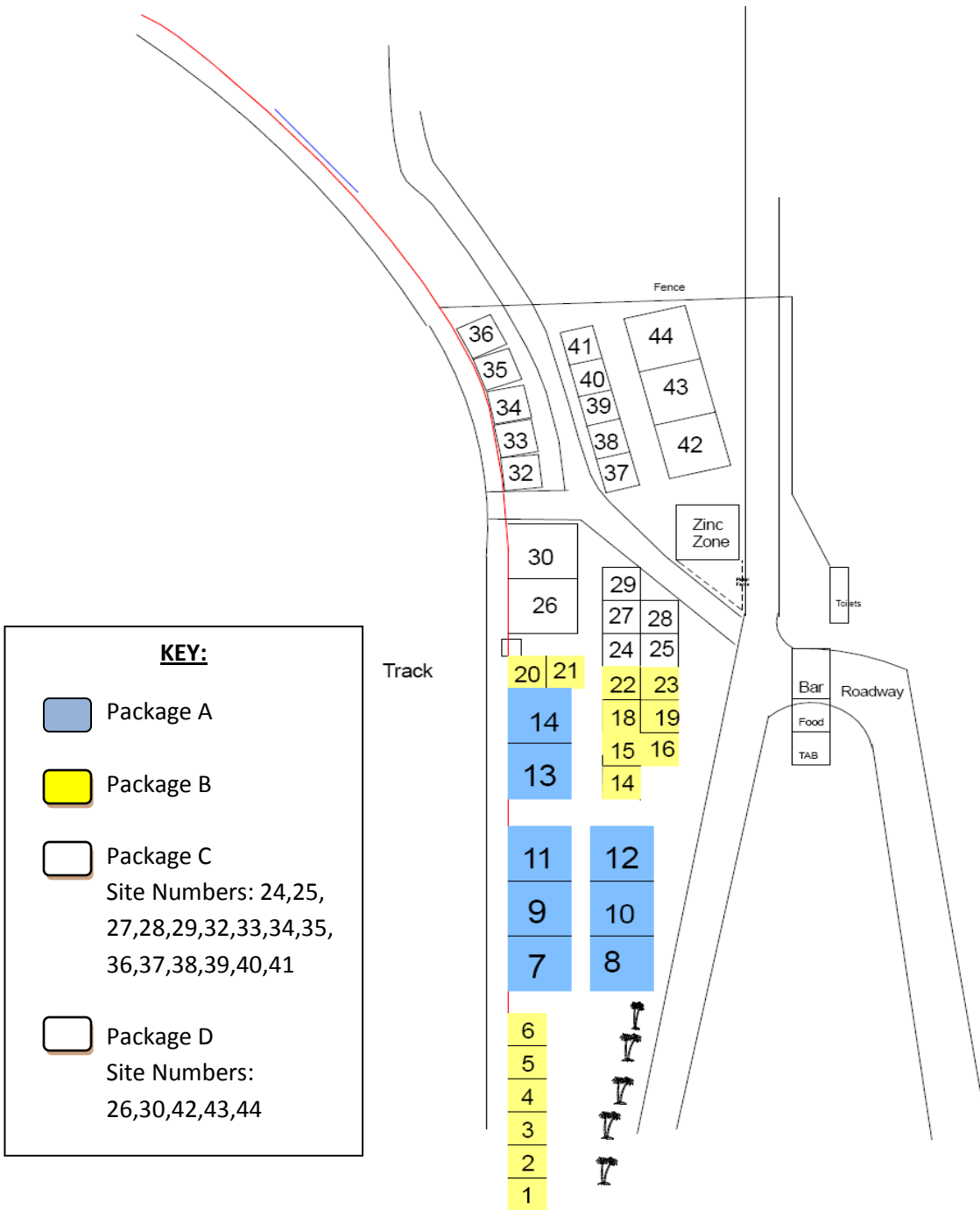
